## Washington County Detention Center

The Washington County Sheriff's Office has participated in the 287(g) program for over 10 years. We also participate in the Internet Crimes Against Children Task Force, the Joint Terrorism Task Force, the Drug Enforcement Agency Task Force, the Gulf Coast High Intensity Drug Trafficking Area Task Force, our own 4<sup>th</sup> Judicial Drug Task Force, the Safe Streets Task Force, and the Emergency Response Team with Fayetteville and Springdale PD. The reason we participate in all of these programs is because the safety of our community has always been, and will continue to be of utmost concern for us, and I believe our participation in these programs helps keep our community safe.

The 287(g) program does not go out into the community and check for illegal immigrants. The program only reviews foreign born individuals who have been arrested on criminal charges and brought to the Washington County Detention Center. Once the review is complete, Immigration and Customs Enforcement makes the decision on whether or not to place a detainer on an individual.
